FOR HYDROCARBON REFRIGERATION UNITS

WARNING

This unit uses R-290 (propane), or R-600a (isobutane) as a refrigerant. These hydrocarbon refrigerants are highly environmentally compatible but also are flammable and combustible. Please read this manual thoroughly before installing and operating the unit. Please take cautious measures to avoid risk of fire or explosion.

PLEASE REFER TO THE LABEL INSIDE THE CABINET TO CHECK REFRIGERATION TYPE AND VOLUME.

FOR HYDROCARBON REFRIGERATION UNITS

WARNING

- The refrigerant tubing, condenser, and evaporator coils are easily prone to damage while handling, moving, installing, and cleaning the unit, which may lead to fire or even explosion.
- Refrigerant squirting out of the pipes could ignite or cause an eye injury. If a leak is detected, avoid any naked flames or potential sources of ignition and air the room in which the appliance is standing for several minutes.
- In order to avoid the creation of a flammable gas-air mixture in case of a leak in the refrigerating circuit, the size of the room in which the appliance is placed depends on the amount of refrigerant used. The room must be 35.31ft³ 1m³ in size for every 0.280z (8g) of R-290 refrigerant inside the appliance. The amount of refrigerant in your particular appliance is shown on the label inside the cabinet.



This appliance contains a small amount of propane (R-290) or isobutane (R-600a) refrigerant, a natural gas with high environmental compatibility, but which is also combustible. When transporting and installing the appliance, care should be taken to ensure that no part of the refrigerating circuit is damaged.

- Never start up an appliance showing any signs of damage. If in doubt, contact a qualified service professional.
- In case of any hazardous activities such as fire or explosion, move the unit away from any source of ignition to a well ventilated area.
- Further service and repair must be done by a qualified technician who is familiar with the safety standards, and also has thorough understanding and knowledge of the flammable refrigerants.
- Any and all technicians handling these units must be equipped with proper personal protection and equipment and follow applicable safety measures and precautions to avoid risk of fire or explosion.

IMPORTANT SAFETY INFORMATION

SAFETY PRECAUTIONS

To avoid any risk of fire, explosion, electric shock, personal injury, material damage or incorrect use of the appliance, be sure to observe the following safety precautions. (After reading these owner's manual instructions, please keep the manual booklet in a safe place for reference. Remember to hand it over to any subsequent owners)

WARNING

- The unit must be installed and located in accordance with the manufacturer's installation instructions.
- Installation work must be performed in accordance with the National Electric Code by qualified and authorized personnel only.
- Component parts shall be replaced with like components and that servicing shall be done by factory authorized service personnel, to minimize the risk of possible ignition due to incorrect parts or improper service
- Do not use an extension cord or an adapter plug. Because of the potential safety hazards under certain conditions, we strongly recommend against any use of an extension cord or an adapter plug.
- Do not, under any circumstances, cut or remove the ground prong from the power cord. For personal safety, this appliance must be properly grounded.
- Do not store volatile and flammable substances in the refrigerator. The storage of benzene, thinner, alcohol, ether, LP gas, or other explosive substances may cause an explosion.
- Do not store or use gasoline or other flammable vapors and liquids in the vicinity of this appliance as well as any other appliances.
- The appliance is not intended for use by children without supervision.
- Do not allow children to climb, stand, or hang on the refrigerator doors or shelves in the refrigerators. They could damage the refrigerator and seriously injure themselves.

INSTALLATION & USAGE

WARNING

- Do not install the unit in a damp place where it could be splashed with water. Incorrect insulation of the electrical parts may cause fire or electric shock.
- Do not plug several appliances into the same sockets. This could cause overheating and risk start of a fire.
- Keep the power plug away from the rear of the cabinet. A damaged power plug may cause fire due to overheating.
- Do not spray water directly to the interior or exterior of the appliance. There is a risk of fire or electric shock.
- Do not place any containers filled with water on top of the appliance. If the water spills onto any electrical parts, it may lead to fire or electric shock.

- If the appliance is not used for a long period of time, unplug it from the power supply. Any deterioration in the insulation may cause fire.
- Do not let children touch or play with the control panel on the front of the appliance.
 - Do not allow children to play with this appliance.
 - Do not stand or lean on the base panel, pull-out parts, or doors.

INSTALLATION INSTRUCTIONS

DAMAGE INSPECTION

Prior to installation, the customer must check for damages with the freight company before the unit is accepted.

1. If the crate is damaged, make sure to note the damage on the Bill of Lading prior to signing the delivery off.
2. Concealed damage must be reported within 5 days of receiving the unit. Bill of Lading must be faxed to the Claims department. Pictures of both unit and crating may be requested.

LOCATION OF OPEN DISPLAY MERCHANDISER

Open Display Merchandisers are designed to be in an area that is ambient 75 degrees Fahrenheit (dry bulb) or colder with 55 percent relative humidity. If the installed unit is in a warm ambient area, it may not be as effective. Position the Merchandiser at its final location before removing the shipping skid. There are four bolts at the bottom of the merchandiser that secure the shipping skid. Remove all four bolts to remove the skid. Allow three inches of space from the wall to the back of the merchandiser. Condenser is located to the front. Do NOT block inlet.

LEVELING THE OPEN DISPLAY MERCHANDISER

Four leveling legs are provided to level your Merchandiser. Use a leveler to ensure the unit is evenly leveled on all four corners. If the unit is not leveled correctly, excess water buildup will not drain properly. If you do not wish to use the levelers, they can be turned inwards.

SEALING CABINET TO FLOOR OR COUNTERTOP

The cabinet must be sealed to the floor for floor-sealed types or to the countertop for countertop-sealed types, following these methods:

1. Preparation
 - Clean the floor or countertop thoroughly, ensuring it is smooth, dry, and free from any debris or contaminants.
 - Ensure the mounting surface is smooth, level, and free of cracks or gaps. Suitable surfaces include stainless steel, concrete, tile, or laminate.
2. Installation
 - Install the cabinet in the desired location.
 - Adjust the cabinet to ensure it is level, with a gap between the bottom of the cabinet and the floor or countertop not exceeding 1/8 inch (3.2 mm).
3. Sealing Process
 - Apply the recommended sealant along the base of the cabinet evenly, covering all contact points between the cabinet and the floor or countertop.
 - Position the cabinet onto the mounting surface, ensuring a complete seal around the base.
 - Apply additional sealant around the outer edges of the cabinet base to ensure a complete seal. Smooth out the sealant with a tool to remove any air bubbles and ensure uniform coverage.
 - Allow the sealant to cure for the recommended time as specified by the sealant manufacturer. Do not move or disturb the cabinet during this time.
4. Recommended Sealing Materials
 - Silicone Sealant: Ideal for smooth and non-porous surfaces, providing a flexible and waterproof seal.
 - Epoxy Adhesive: Suitable for rough or uneven surfaces, offering a strong, rigid bond.
 - Polyurethane Sealant: Provides a durable and weather-resistant seal, suitable for various surface conditions.
5. Sanitary Statement
 - This equipment must be sealed to the floor or countertop to maintain proper sanitary conditions, preventing contamination and facilitating easy cleaning.
 - Once sealed according to these procedures, the equipment is designed to prevent any liquid spillage on adjacent surfaces from passing under inaccessible portions of the equipment, ensuring a hygienic and safe environment.



OPERATING INSTRUCTIONS

Level and set your merchandiser in place. Connect all necessary electrical connections. Your Open Display Merchandiser should now be ready for use.

POWER SWITCH:

Located at the bottom of front panel.

LIGHT SWITCH:

Located at the bottom of front panel.

TEMPERATURE CONTROL:

Located at the bottom of front panel.

HOW TO SET THE TEMPERATURE

1. Press the SET button  for 1S to check the temperature setting.
2. The display panel shows the current temperature setting.
3. To change the temperature, press the UP  or DOWN  button and press the SET  button when adjustment is complete.
4. The temperature setting has been changed and the display panel shows the current temperature.

MANUAL DEFROST

1. Press the DEFROST button  for 3S to begin a manual defrost.
2. Defrost mode will be off automatically when it is complete
3. During the defrosting process, pressing the DEFROST button  for 3S will stop defrosting and turn off the defrost mode.

Thermometer showing temperature is located on the right side of the front panel.

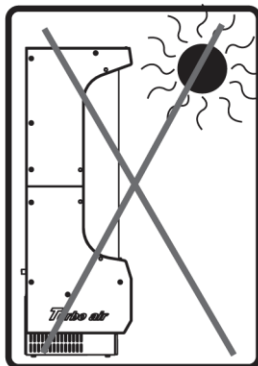

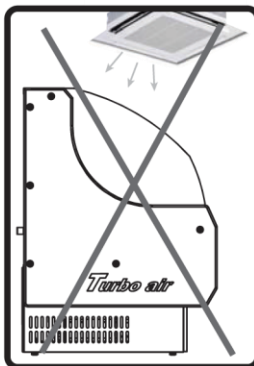
PRODUCT PLACEMENT:

Overloading of product or placing products against the back wall or suction grill may cause disruption in air flow, which may cause the unit to not cool properly.

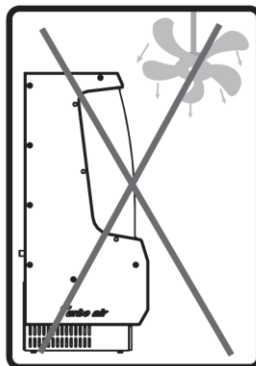

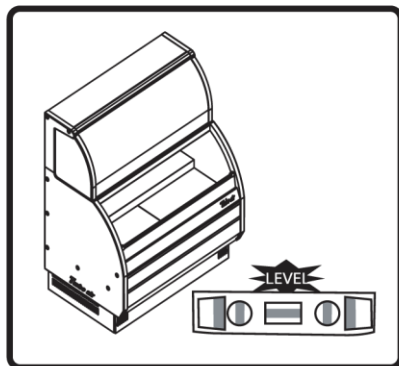
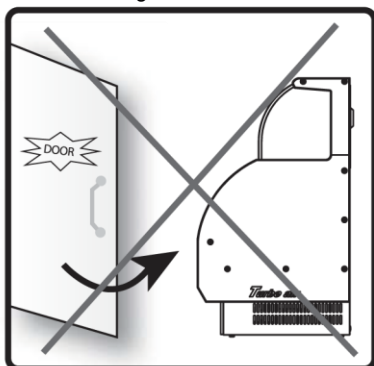
- Units should not be placed in direct sunlight.



- Units should not be placed near HVAC vents.

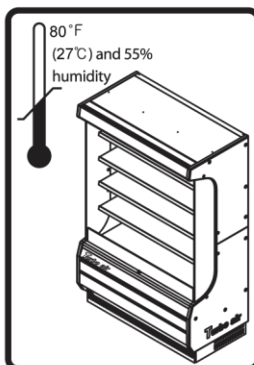
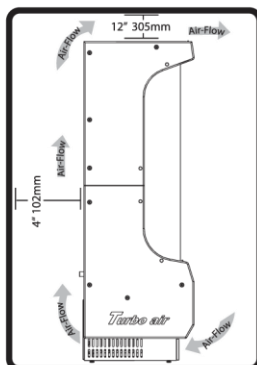


- Units should not be placed near fans.



- Level the cabinet on all four corners of the base.

- Confirm there is enough clearance for proper air circulation



- Operating environment not to exceed 80°F (27°C) and 55% humidity.
- Do not load product beyond the edge of the shelf

MAINTENANCE & CLEANING

Always turn off your unit (both power and lights) when cleaning. Remove all products and allow your unit to reach room temperature. Do not allow electrical components to get wet.

CLEAN YOUR OPEN DISPLAY MERCHANDISER THOROUGHLY BEFORE FIRST USAGE.

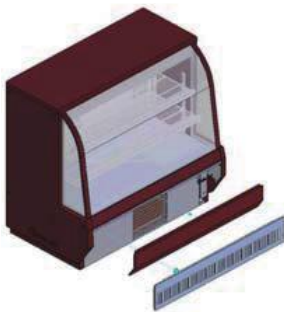
- a. Do not clean with harsh detergents. Use mild soap.
- b. Remove all products.
- c. Remove shelves and bottom trays.
- d. Clean interior with warm water and mild detergent.
- e. Wipe with damp cloth. Do not leave soap residue.

CLEANING THE DRAIN

The Drain is located beneath the bottom shelf. Clean it regularly to prevent rust and water leakage.

CLEANING THE CONDENSER COIL

Condenser coil is located at bottom behind panel.



1. Disconnect the electrical power from the unit.
2. Remove the front cover and base cover with screw driver.
3. Brush the dirt, lint, etc. from the finned condenser coil.
4. When finished, be sure to replace the front cover and base cover.
5. Reconnect the electrical power to the unit.

NOTE:

For a self-cleaning condenser equipped model, condenser cleaning is not required. However, it is recommended to blow the condenser coil out with Nitrogen once or twice a year. Note that the condenser cleaner may not remove grease.

TROUBLESHOOTING

For any problems with your unit, please refer to the following check list. If you are still experiencing problems or have questions, please call the Customer Service line at 1-800-381-7770.

I. MERCHANDISER NOT FUNCTIONING

- a. Check to see that the breaker hasn't tripped.
- b. Check that enough power is BEING supplied to the unit.
- c. Check that the power switch is on.

II. MERCHANDISER NOT FUNCTIONING

- a. Check the condenser to see if it is clean.
- b. Check that the inner airflow is not being blocked by products.

III. MERCHANDISER NOT FUNCTIONING

- a. Check that light switch is on.
- b. Check that the lights are placed in the lamp holders correctly.

TWO (2) YEAR WARRANTY

Warranty Claims...

All claims for parts or labor must be made directly through Turbo Air. All claims should include: model number of the unit, the serial number of the cabinet, proof of purchase, date of installation, and all pertinent information supporting the alleged defect. In case of compressor replacement under warranty, either compressor or compressor tag must be returned to Turbo Air along with above listed information. Failure to comply with warranty policies will result in voiding claims.

Two-Year Parts & Labor Warranty...

Turbo Air warrants all new refrigerated components, the cabinet and all parts, to be free from defects in materials or workmanship, under normal and proper use and maintenance service as specified by Turbo Air and upon proper installation* (indoor building only and start-up in accordance with the instruction packet supplied with each Turbo Air unit. Turbo Air's obligation under this warranty is limited to a period of two (2) years from the date of original installation or twenty seven (27) months after shipment date from Turbo Air, whichever occurs first. Any part covered under this warranty, that is by Turbo Air to have been found defective within two (2) years of original installation or twenty seven (27) months after the shipment date from manufacturer, whichever occurs first, is limited to the repair or replacement, including labor charges, of defective parts or assemblies. The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by Turbo Air. (*Installation in unstable, mobile, and enclosed area may not be considered as proper installation.)

Additional Three-Year Compressor Warranty...

In addition to the two (2) year warranty stated above, Turbo Air warrants its hermetically sealed compressor to be free from defects in both material and workmanship under normal and proper use and maintenance service for a period of three (3) additional years from the date of original installation, but not to exceed five (5) years and three (3) months after shipment from the manufacturer. Compressor determined by Turbo Air to have been defective within this extended period will, at Turbo Air's discretion, be either repaired or replaced with a compressor or compressor parts of similar design and capacity. The three (3) year extended compressor warranty applies only to hermetically sealed parts of the compressor and does not apply to any other parts or components, including, but not limited to, cabinet, paint finish, temperature control, refrigerant, metering device, driers, motor starting equipment, fan assembly and/or other electrical components, etcetera.

R-290/R-600a Hydrocarbon Compressor Warranty...

The three-year compressor warranty detailed above will be void if the following procedure is not carefully adhered to:

1. This system may contain R290 refrigerant and polyol ester lubricant. The polyol ester lubricant has rapid moisture absorbing qualities. If long exposure to the ambient conditions occur, the lubricant must be removed and replaced with new.
2. Drier replacement is very important and must be changed when a system is opened for servicing. Drier with XH-7 molecular sieve or better must be used.
3. Micron level vacuums must be achieved to ensure low moisture levels in the system. 500 microns or lower must be maintained.
4. Compressor must be obtained through Turbo Air, unless otherwise specified in writing, through Turbo Air's warranty department.
