- Must have annual family income of less than \$90,000 with supporting documents

- Physical or e-copy of official transcript is acceptable.
- 2023 & 2024 Tax return form (copy of the first page of the federal income tax return showing the Adjusted Gross Income)
- The applicant must be either;
- 1) listed as a dependent in the tax return form of their respective parents/guardians or,
- 2) listed as the tax payer with self-exemptions in the tax return form.*
 - * In the case of 2), it is required to submit the parent's income tax return copies along with documentation to verify the relationship with the applicant, such as a birth certificate.

- · Scholarships will be given based on academics and financial needs in priority of
- 1) Number of students in the family, 2) Total family income, 3) GPA, 4) Major
- Scholarship will be paid in check and will be mailed to the applicant after 4-6 weeks from the receipt of the application
- · Funds must be applied to expenses such as undergraduate tuition, fees, books
